1. Background

Prevention of marine litter input from land-based sources is of important measures for solving marine litter problem. Therefore, CEARAC published "Regional report on measures and best practices for prevention of marine litter input from land-based sources in the NOWPAP region" and pamphlet "Best practices for prevention of marine litter input from land-based sources in the NOWPAP region" in 4 NOWPAP member state languages and English. To promote prevention measures in each member state, CEARAC proposed new activity "Developing a report of case studies on basin-wide collaborative actions for prevention of marine litter input from land-based sources in Japan" for the 2014-2015 biennium.

At the NOWPAP Marine Litter Working Meeting (26 October, Okinawa, Japan), workplan and budget of NOWPAP marine litter activities for the 2014-2015 biennium were discussed. CEARAC proposed a new activity. The 18th NOWPAP IGM (December 2013, Toyama, Japan) approved the workplan and budget of NOWPAP Regional Action Plan on marine litter for the 2014-2015 biennium with the budget US\$70,000. CEARAC was allocated US\$6,000 and will conduct the following activities in this biennium.

2. CEARAC marine litter activities

> <u>Developing a report of case studies on basin-wide collaborative actions for prevention of marine litter input from land-bases sources in Japan.</u>

Objective:

The sources of drifted marine litter are predominantly land based. Thus, effective countermeasures for preventing land-based marine litter input are needed to reduce the volume of marine litter input to the NOWPAP sea area. To provide useful information to the NOWPAP member states, CEARAC published "Regional report on measures and best practices for prevention of marine litter input from land-based sources in the NOWPAP region" in 2013. To share such countermeasures among member state contribute to resolving marine litter issue in the NOWPAP region. From such point of view, in the 2014-2015 biennium, CEARAC plans to publish a report of case studies on basin-wide collaborative actions for prevention of marine litter input from land-based sources in Japan.

Main Tasks:

1. Collecting information on basin-wide collaborative actions for prevention of marine litter input from land-based sources, implemented at Oyabe-River river basin in Toyama, Japan

2. Preparing a report on case studies on basin-wide collaborative actions
