Annotated Provisional Agenda

Background leading to the meeting

The Special Monitoring and Coastal Environmental Assessment Regional Activity Centre (CEARAC) is one of the four Regional Activity Centres (RACs) to coordinate activities relevant to specific components of the Action Plan for the Protection, Management and Development of the Marine and Coastal Environment of the Northwest Pacific Action Plan (NOWPAP). Since its inception in 1999, CEARAC has been mainly working on monitoring and assessing harmful algal blooms including red tides (under Working Group 3) and application of remote sensing techniques to the study on the marine and coastal environment (Working Group 4).

Since 2008, when CEARAC initiated an activity on eutrophication as a joint work of WG3 and WG4, its foci has shifted to eutrophication, marine biodiversity, and seagrass and seaweed. CEARAC has implemented several activities during the past biennia on these areas by using the knowledge and experiences in working on HABs and applying remote sensing techniques at the same time.

In recent years, based on the outputs and outcomes of the specific projects in each biennium as well as in accordance with the directions of the NOWPAP Medium-term Strategy (MTS) 2012-2017, the Secretariat of CEARAC has developed its draft workplan and budget for every biennium.

While reviewing the progress of the planned activities for the 2014-2015 biennium, the 13th CEARAC FPM (25-26 August 2015, Toyama, Japan) discussed proposed activities for the 2016-2017 biennium, which was agreed to be submitted to the twentieth Intergovernmental Meeting (IGM) held on 28-30 October, 2015 in Beijing, China for adoption.

The 14th CEARAC Focal Points Meeting (FPM) will be held in Toyama, Japan on 7-8 April in 2016 to review the progress of its current activities for the 2016-2017 biennium.
