## **Annotated Provisional Agenda**

#### **Background leading to the meeting**

In recent years, CEARAC has implemented activities on marine biodiversity, seagrass mapping and marine litter as well as some follow-up work on eutrophication and harmful algal blooms (HABs). Seagrass is one of the important coastal habitats for marine spices and their ability to capture carbon (blue carbon) has gotten much attention globally. CEARAC developed a manual for seagrass and seaweed bed distribution mapping with satellite images in 2015 and validated its applicability in the entire NOWPAP region.

CEARAC focused on eutrophication, invasive species and habitat alteration as main threats to marine biodiversity in the NOWPAP region and assessed their status and impacts with the support by national experts of the member states. The analysis was compiled as an assessment report published in 2018.

While CEARAC has delivered certain outcomes by its projects, lack of NOWPAP's clear vision on conservation of marine biodiversity has obstructed CEARAC to pave the way for its future actions. Thus, at the 15<sup>th</sup> CEARAC Focal Points Meeting (FPM) held in 2017, CEARAC Secretariat proposed one project under the theme of marine biodiversity: development of a CEARAC Medium-term Strategy on marine biodiversity (MTS). CEARAC also proposed to develop of a tool for mapping seagrass distribution in the NOWPAP region in 2018-2019 besides some routine work such as organization of meetings and maintenance of the website.

After discussion, the meeting approved the proposed workplan of CEARAC with applying some modifications and agreed to submit it to the 22<sup>nd</sup> NOWPAP Intergovernmental Meeting (IGM) held later in 2017.

Then, the 22<sup>nd</sup> IGM approved the NOWPAP workplan for the 2018-2019 biennium with higher budget allocation than the previous biennia. Following this decision, CEARAC decided to add another activity to its workplan: development of a roadmap for Regional Action Plan for Marine and Coastal Biodiversity Conservation (RAP BIO) which could complement development of CEARAC MTS.

At the 16<sup>th</sup> CEARAC FPM held in May 2018, the meeting carefully reviewed the revised workplan with detailed tasks and the progress of respective activities. The meeting discussed how much work could be done within two years (2018-2019) with clear outcomes. At the same time, the meeting strongly recommended cooperation and coordination with other RACs, especially for development of a roadmap for RAP BIO as it should be one of the major outcomes of NOWPAP Medium-term Strategy 2018-2023.

Coming to the end of the 2018-2019 biennium, the 17<sup>th</sup> NOWPAP CEARAC FPM will be held on 9-10 September 2019 in Toyama, Japan to review the progress of the current CEARAC activities and discuss workplans proposed by CEARAC Secretariat for the 2020-2021 biennium.
